Through his counsel, Andrew Rottman, responds to the Colorado Commission on Judicial Discipline’s (“the Commission”) Motion to Extend Briefing Schedule as follows:

1. Mr. Rottman received a copy of the Commission’s Motion late on Friday afternoon, June 2, 2023. In that Motion, the Commission represents to the Special Tribunal that the “Commission understands that the Parties are conferring to address and potentially render the

issues upon which this Special Tribunal has directed briefing moot.” Counsel for Mr. Rottman has made clear to all parties his position of the conditions upon which a revised stipulation will make the briefing moot and has invited any and all counsel to confer with him should any questions arise as to his position.

2. Under the circumstances, Mr. Rottman does not object to the Motion to Extend Briefing Schedule an additional 14 days to allow the Commission to respond. Depending on the wording of any revised stipulation, Mr. Rottman will advise the Special Tribunal whether he agrees that the scheduled briefing is moot or that he wishes to proceed with his Motion and the requested relief therein.
