On November 13, 2025, Judge MacLaren filed a motion seeking an order that the Rules of Civil Procedure shall govern the formal disciplinary hearing in this case. As the Commission explained in its November 21, 2025 response, the Commission does not oppose that request. If the Panel is not yet ready to issue an order on this issue, the Commission asks the Panel to set a status conference to address any questions or concerns. Counsel for the parties have conferred, and the Commission submits the attached proposed Order that would address this and related procedural issues in this case. Counsel for the parties have conferred about this proposed order, and counsel for Judge MacLaren does not oppose the Commission’s proposed order.

In the alternative, counsel for Judge MacLaren does not oppose the request for a status conference to address any questions the Adjudicatory Board may have on this issue.
