Initial Contact (14 June 2025)

On June 14th, 2025, at approximately 1940 hours, I, Officer Snyder, was on boat patrol at McPhee Reservoir in Montezuma County, Colorado, with Officer Alejos when we noticed a white ski boat (██████████) with a Gekko logo and expired 2024 registration decals occupied by two adults towing a child on a tube. The child was wearing his lifejacket (PFD) while the adults did not have visible PFDs. The observer used a flag to indicate that the skier was in the water. The flag was severely tattered and discolored to the point that it was not visible within 100 yards of our position.

Officer Alejos initiated the contact and introduced himself. Officer Alejos asked the operator (later identified by his Colorado Driver's License as Ian MACLAREN DOB ██████████) if he possessed a valid 2025 registration. MACLAREN claimed he had not registered the vessel this year. Officer Alejos asked MACLAREN if he operates the boat often. MACLAREN claimed he often operates the boat on McPhee reservoir "every night he can" because he lives nearby. MACLAREN further claimed he knew he needed to register his vessel but hadn't done so this year. Officer Alejos asked if they had a better flag available. MACLAREN did not. We gave MACLAREN a new ski flag. Officer Alejos initiated a vessel safety inspection and found no further violations.

Officer Alejos verbally warned MACLAREN that he needed to register his vessel and informed him he could not continue to operate until the registration was validated. MACLAREN asked if he could pay the citation and continue to operate his vessel. Officer Alejos informed MACLAREN he could not. We broke contact, and no further action was taken that evening.

Follow-up Contact (15 June 2025)

On June 15th, 2025, at approximately 1755 hours, I, Officer Snyder, was on boat patrol at McPhee Reservoir in Montezuma County, Colorado, with Officer Alejos when we noticed the same white ski boat with a Gekko logo and matching registration numbers from the day before (██████████). The registration decals were still expired from 2024.


Upon approach, I reintroduced myself and asked MACLAREN if he had updated his registration. MACLAREN claimed he had not. I asked MACLAREN why he had not updated his registration and reminded him of the verbal warning from the day prior. MACLAREN claimed he had tried to register the boat online and via phone but was unable to do so due to technical difficulties. I informed MACLAREN that the nearby Mancos Lake State Park Office and Durango Area Office were available to update boat registrations. MACLAREN claimed he did not have time due to his occupation as a Judge. I reiterated that all vessels in Colorado must have a valid registration to be operated on public waters. I asked MACLAREN if he had corrected any other violations from the day prior. MACLAREN reminded me that there were no other violations and provided his equipment for inspection. I asked MACLAREN for his identification, and he claimed he left it in his truck at the McPhee boat ramp. I asked MACLAREN to meet me at the boat ramp with his identification.

Once at the ramp, MACLAREN provided his driver's license. I issued MACLAREN citation #F560033 for Colorado Revised Statute 33-13-103(1) for unlawful operation of an unregistered vessel.

MACLAREN signed the citation in understanding. Video recording of the citation is available upon request. I provided him with his blue copy, payment information card, and his identification. I reminded MACLAREN that he was still not allowed to operate without a valid registration. MACLAREN claimed he should still be able to operate his vessel, but understood the order. MACLAREN was polite and understanding regarding the citation. I took no further action and was clear/available at approximately 1820 hours.
