

**Notice of Rulemaking and Public Comment Hearing:**  
**Colorado Rules of Judicial Discipline, Interim Rules 35 and 36**

The Judicial Discipline Rule-Making Committee has approved two additional interim rules. A copy of each interim rule, along with a redline comparing the interim rule to the prior rule, is available on the Commission on Judicial Discipline's website at <https://ccjd.colorado.gov/judicial-discipline-rule-making-committee>.

- Interim Rule 35: Resolution of Informal Proceedings or Other Actions (effective September 9, 2025)
- Interim Rule 36: Resolution of Formal Proceedings (effective September 9, 2025)

The Committee will hear public comments on these rules, as well as three previously-announced interim rules (Colorado Rules of Judicial Discipline 3.6, 34 and 37(e)), at a public comment hearing on October 3 at 9 AM at 1300 Broadway, Denver, Colorado, 80203 in room 2A.

The intent of an interim rule is to address pressing issues without delay. Each interim rule will be replaced by a final rule at a later date. The public will have additional opportunity to submit public comment when an interim rule is replaced with a final rule.

### **Oral Comments**

Members of the public may submit oral comments either in person or remotely.

To be added to the agenda for an oral comment, either in person or online, you must include your full name in the email.

The Committee may limit the length of oral comments as needed to ensure that all interested members of the public have an opportunity to comment. An announcement will be made at the beginning of the hearing regarding any time limitation on comments.

### **Written Comments**

If you would like to submit a **written comment**, the comment period is now open. Written comments will be accepted until 5 pm on September 30. To submit a comment in writing, please email [rulemaking@jd.state.co.us](mailto:rulemaking@jd.state.co.us) with the subject line "Public Comment." Please attach your submission as a separate document to your email in Word or PDF format. To be accepted, your written comment must include your name.
