## Commission on Judicial Discipline

### Request for Evaluation of Judicial Conduct

The [Colorado Code of Judicial Conduct](#) establishes standards for the ethical conduct of judges and those seeking judicial office. A judge's conduct in the courtroom and in the community is guided by certain principles, known as the Canons, contained in the Code.

The Commission is not an appellate court and **cannot review, reverse, or modify a decision or ruling made by a judge**. A Request for Evaluation is not an appeal and does not extend the timeline within which to file an appeal. The Commission has jurisdiction over all Colorado District Court Judges, County Court Judges (except Denver County), Court of Appeals Judges, and the Justices of the Colorado Supreme Court. The Commission **does not have jurisdiction** over attorneys, Magistrate Judges, Municipal Judges, Denver County Court Judges, Administrative Judges, or US Federal Judges.

The Commission will accept anonymous Requests for Evaluation via mail and email. If you choose to submit your request anonymously, please fill out the RFE pdf form below and include all information the Commission will need to evaluate your request. Please also be aware that, if you file an anonymous Request for Evaluation, the Commission will not be able to advise you of the resolution of the request. The Colorado Constitution makes the Commission on Judicial Discipline's records confidential unless and until the Commission, after evaluating a Request for Evaluation, initiates formal disciplinary proceedings.
